Chief's Report for the month of May 2022

543 calls

- Higher than usual primarily due to an increase in security checks and traffic stops
- One (1) felony – forged prescriptions from a doctor's system
- Four (4) misdemeanors
- Two (2) vandalism (broken windows)
- One (1) domestic battery resulting in an arrest
- One (1) license plate being stolen from a resident's driveway

CHP – Officer Tyler Hahn

May 10-June 14

- 308 traffic collisions this year within Dublin CHP area; 2 collisions around Blackhawk
- Fatalities are down year-to-date
- 14 new volunteers being onboarded to complement the 12 existing volunteers. This should result in increased CHP presence in the Blackhawk area.

HOA – Hank Schultzel, President

2 security issues being addressed:

1. ~300 Blackhawk Country Club employees have been using the visitor lane to gain access to Blackhawk. They will be moved to the transponder system which should result in gaining a better handle on who is coming in and out of Blackhawk
2. There will be a new password management process implemented for club events to tighten use of passwords.

Old business – Ron Banducci, P2A Chair

- By-laws will be on June 28 County Supervisor agenda. This is the final step to secure Blackhawk P2A by-laws.
- P2A committee write-up has been distributed to all Blackhawk area HOAs. That information has been made available to residents and will be complemented with the upcoming Blackhawk HOA newsletter as well as the Blackhawk Beat.

New business – Ron Banducci, P2A Chair

- Preparedness for potential public demonstrations was addressed by Chief Schultz who outlined both the County and local resources available to handle this if needed.
- The County Administrator's office is preparing a five-year proforma fiscal projection for the Blackhawk Police.
