- 3) Stephanie defers item to approve June 9 meetings, due to lack of quorum at 10:20
- 4) Announcements:
 - a) Rebecca: CoCo Public Defender's Office and Reentry Solutions Group have been advancing the issue of eliminating Juvenile Justice fees charged to parents; Jill Ray says that Supervisor Gioia has asked for this matter to be on BOS agenda for next Tuesday, 7/19, recommending that it be formally referred to the PPC; Jill confirms that it is on the BOS agenda.
 - b) Rebecca: Art celebration at the Reentry Center, 8/15/16 7-9
 - c) Donté: WDB is creating a grant-funded program for workforce development and supervised populations, using CCP funds as a match
 - d) Belinda: Reach's 2nd gender-responsive conference 9/22 9 AM - 3 PM at Richmond City Council
- 5) Public comment:
 - a) Donté: "Reentry guide" funded by AB109: CoCo Crisis Center/211 is managing this deliverable, creating a special section on their website, and they're also providing trainings on how to use that guide, and apps are now available, so hereafter CoCo Crisis Center/211 will need funds for upkeep – may request increased AB109 funding in subsequent years, which is something that CAB want to consider in planning the 17/18 funding request
 - b) Joe Partansky: Police Chief from Seattle has a new book on policing
 - c) Donté provides update on the planned dissolution of the Network Team and CAO's anticipated recommendation that the management funds will go out to contract with an organization, rather than independent contractors.
 - d) Arlinda: Presentation will be made at the Martinez hospital by Anna Roth today for people who have lost family members to gun violence, 12-2

6) Presentation on County Pre-Release Planning Project:

- a) Mikaela and Lark present slide deck on the project
 - i) Reviews origin of project and history to date
 - ii) Next meeting is Monday, 7/18, to develop governance structure and data planNew Reentry Transition Specialist (RTS) is funded through CCCoE; originally planned to hire an educational transition specialist but has now reshaped that as reentry transition
- b) Donté says that there was a public presentation at QAC in June
- c) Questions:
 - i) Kathleen asks whether there's been attention to "closing the loop" on referrals; Mikaela says this is something they're "talking about," with Network and Center as primary mechanisms for referral
 - ii) Kathleen also asks whether not just planning but implementation work (family, employment, housing) will be done while people are still inside; Mikaela says that's one of the goals.
 - iii) Angelene asks about the Reentry Transition Specialist; is that the sole person doing assessments and referrals, given that it's 36 people per week? Mikaela says that it will "leverage" in-custody providers; doesn't specify whose these in-custody providers might be.
 - iv) Lara says that the group of 36 will participate in an overview, and the plan will use two assessments (for short term and long term people)
 - v) Arlinda asks what will happen post-release: who will provide post-release continuity and navigation; Candace talks about Miller Wellness Center, and that it's available but many have trouble getting there.
 - vi) Angelene says that she hopes that the RTS budgets for time to assessment, develop plan, and connect to multiple other agencies
 - vii) Nic says he shares concerns about screening and referrals, and he is also concerned about the mechanism of referrals, and believes that the transition specialist should have direct referral mechanisms to providers, and not just through Reach and MWP to implement each plan. Also concerned about capacity on the outside to fulfill the individual plans – if there's insufficient capacity on the outside, then the pre-release planning doesn't much matter; what would really be going on would be providing information, rather than developing and implementing a true plan.
 - viii) Mikaela says that the RTS would be responsible for managing the project.
 - ix) Mikaela also says it may be that "resources" exist but are not adequately accessed (such as public benefits).
 - x) Nic suggests the pilot should focus on narrow elements, such as public benefits or IDs.
 - xi) Rebecca expresses variety of concerns about the feasibility and operationalizability of the project.
 - xii) Rhody says that the pilot should be more specific, and that the plan doesn't adequately address the realities of the limited transition release.

- xiii) Rick asks how this is different from the Center and Network? Donté says they have different functions – this project is an element within the idea of service identification and implementation.
- d) 11:15 AM: Stephanie calls item to approve the June 9 CAB minutes, given that quorum has been establishedStephanie moves to accept the minutes with minor clarification on item three (the date of the July CAB meeting), Jason seconds, all in favor

- 1) Stephanie calls to order at 11:07
- 2) Announcements:
 - a) Lynette Hasan-Marshall: formerly Santa Rita jail and worked as job developer, for last 19 years teacher and outreach at Alameda County Sheriff's Office, new Reentry Transition Specialist for CCCoE, will be working on the new prerelease project
 - b) Rick Fortenberry: Backpack giveaway event 8/27, 3-6 PM, Nicholls Park in Richmond
 - c) Ed: Supervisor Glover is holding grantwriting workshop on 9/27 at Crockett Community Center, registration on Glover's web page
- 3) Public comment: None
- 4) Membership recruitment process review from Donté
 - a) Donté reminds CAB to create a timeline, summarizes need for recruitment, with reviews done in public venues, though certain information can be kept confidential – Donte will re-do application to include one page that can be kept confidential (available only to the Ad Hoc committee); will submit it to next month's CAB agenda
 - b) Donté says that the confidential information could be distributed only to the Ad Hoc committee, to the officers, or to the full CAB – that decision will be up to CAB.
 - c) Programs and Services committee will offer report later in today's meeting
- 5) Stephanie reporting on CCP meeting of 8/5
 - a) Lara summarizes the changes in the Network Team services and the process for RFP. She says they're now drafting the RFP, but the timeline for distribution may be pushed back a week or two, for contract in October, start-up through December, and operational by January.
 - b) Lara says she will send a copy of the draft RFP to Stephanie, and CAB is welcome to "provide input." Stephanie says she will be CAB's point person on this for now.
 - c) Harlan: Will ability to hit the ground running be a factor? Lara says capacity to implement on a timeline will be considered.
 - d) Donté says that he would work with the contractor to foster start-up. In the interim, will require Probation to make direct referrals to service providers between October and January. While contract might start in October, will likely still need to be developing No Wrong Door agreements, recruiting mentors, building relationships with local stakeholders, including if applicants are coming in from outside county.

- e) Stephanie asks what will happen to clients who have built relationship with Field Ops, Lara says the relationships have been primarily intended to be with Mentor/Navigators and not with the Field Ops.
 - f) Steph asks who will be supporting/coordinating the Mentor Navigators in the interim; Lara says they can continue to use the case management system. Donté adds the contracts with the Field Coordinators will be extended through September to allow for wind-down transition.
 - g) Rachelle asks whether this transition will affect the prerelease pilot; Lara says it won't affect that.
 - h) Chrystine expresses concern about Network winding now, concern that there will be a lag in services, and that the network has been intended as linkages.
 - i) Talia says that this is a complete lack of services for 90 days, and we need to come up with methods to continue services for clients. Talia suggests that at least one person stay on contract longer so that there's some continuity. Donté says that service transitions are not uncommon in county contracts, and it's a reality; that to extend the current contracts would diminish amount available to the subsequent contract. Also clarifies that the service contracts are remaining in place, so those will still be available – what will change is the infrastructure to make those connections.
 - j) Talia asks, if there's no gap stemming from the termination of the Network Field Coordinators, then what's the value added of having a network at all? Donté says that there are elements that can be retained for a short period of time as others temporarily step up; and it's important to create enough launch time.
 - k) Angelene offers appreciation for the fact that the county stepped in to recognize that the Network wasn't working. But also feels that East County is "being shafted," that there will be a hole in services, hopes that Probation will step in to support, but the Network is intended to create a warm handoff and referrals from other than Probation, and that gap will be meaningful to her for the several months.
 - l) Rachelle says that she thinks the county is moving forward positively, but she wants to know whether they should continue making presentations about the Network; until 9/30, will there be a plan for modified services? Lara says "the only thing that will change is the Network team." Rachelle asks that the County provide some summary of what the changes will be.
 - m) Pat says that the majority of the service providers are already going in to make presentations.
 - n) Rebecca suggests that the Network Manager be tasked with developing a transition plan; asks CAB whether they want to make a formal request for the creation of a transition plan. Stephanie says that she can take a look at that idea with Donté and Lara.
- 6) Reports on the August CCP meeting:
- a) Stephanie:
 - i) Pre-release project; Donté and Lara and Stephanie will be working on that.
 - ii) CCP approved use of rollover funds by Center
 - iii) Presentation on Office of Reentry and Justice, which Angelene will report on later in this agenda
 - b) Harlan commends the presentation Nic of the Reentry Center made at CCP

 - ii) At CCP, CAB made recommendations related to leadership structure. CCP did not vote in response to the CAB's requests, but it looks like CCP will present to PPC without changes, scheduled for September 26, 2016 PPC meeting. CAB has concerns about division of roles and responsibilities, about the high level of county administrative management.
 - iii) Rebecca expresses concern about the division of duties and areas of subject matter expertise; is concerned that the Office of R+J should be directed by someone with such expertise, and doesn't understand why the project requires bureaucratic oversight of .9 FTE of a Senior Deputy County Administrator, since the expertise for a CAO is so different from that of a criminal justice specialist. Lara replies that she has "great qualifications, with more expertise than others who would be involved in the office," and concludes that "This is what the County Administrator wants, so if you want an Office of R+J, this is what you need to take."

You're Invited to Apply to Serve on the Community Advisory Board to Advise the Contra Costa County Community Corrections Partnership!

Today, you have an opportunity to help guide an important reentry process now under way in counties across the state of California.

California Assembly Bill 109 (“AB 109”), also known as the Public Safety Realignment Act, is a new law designed to reduce the overcrowded prison population and decrease recidivism through the use of new and innovative approaches to corrections and reentry into the community. To accomplish these goals, AB 109 shifts responsibility for incarceration and supervision of low-level offenders from the state level to the local county level. The major components of the Act went into effect on October 1, 2011.

AB 109 directs each county to convene a Community Corrections Partnership (CCP) to oversee the development of a plan to implement the realignment changes on a county level.

The CCP is governed by an **Executive Committee** of seven members.

This group has been meeting regularly since July 2011 to draft the county’s Realignment Plan and budget allocations. The initial Plan was approved by the Board of Supervisors in October 2011, with the intent that the Plan is an ongoing project that will be revised and adjusted as the group evaluates the progress of the realignment process. In fall 2012, the Executive Committee convened an Ad Hoc Operational Planning committee to develop an Operational Plan, which was adopted by the Executive Committee on November 9, 2012.

To ensure community involvement and strong communication, the Executive Committee convened a group of 12 community members in December 2011 **to act as a Community Advisory Board (CAB) to the Community Corrections Partnership.**

CAB is seeking new Members to fill four (4) upcoming vacancies.

Why get involved? As realignment implementation continues, the Community Advisory Board will provide a meaningful opportunity for community members to inform and improve the County’s realignment process.

Purpose and responsibilities: The CAB will: Provide input on community needs; Assess implementation of the realignment plan; Review data on realignment outcomes; Advise the CCP on community engagement strategies; Offer recommendations for ongoing realignment planning; Advise County agencies regarding programs for implementation in the County; Encourage outcomes that are consistent with the County’s Reentry Strategic Plan

Eligibility and attributes: CAB members must live or work in Contra Costa County. CAB members may include representatives of community groups, service providers working with people with criminal backgrounds, members of the criminal justice system including advocates for alternative methods such as community courts and restorative justice, subject-matter experts and other interested individuals. Emphasis will be placed on ensuring geographic representation from parts of the county most impacted by reentry.

CAB will have formerly incarcerated individuals and the families of incarcerated or formerly incarcerated people as well as crime victims and the families of crime victims. Formerly incarcerated individuals and individuals impacted by crime are encouraged to apply. If you or a family member have been incarcerated or impacted by crime, please describe how your experience with the criminal justice system will inform your participation as a CAB member.

Though the selection process the CAB is committed to creating an advisory body that is inclusive and diverse in regards to gender, ethnicity, age, and ability.

Commitment: Members of the CAB agree to participate in up to two meetings per month, from January 2017 to December 2017. These meetings include a monthly meeting of the CAB held in Martinez, or as designated by the CAB, and CAB members must make the effort to attend at least half of the CCP Executive Committee meetings held in Martinez.

CAB members are required to attend all regularly scheduled CAB meetings. Members may miss up to three (3) meetings for any reason. Members who are absent from four (4) meetings will automatically be removed from CAB.

In addition to attending CAB meetings, members must participate in CAB projects and/or working groups. Currently, the CAB has two standing committees – (1) Programs and Services and (2) Data and Evaluation. CAB members also hold seats on the Contra Costa County Reentry Success Center Steering Committee, CCP Quality Assurance Committee (QAC), and have previously participated in review panels for reentry related county based funding opportunities.

The CCP will review and provide final approval of recommendations for membership to the Community Advisory Board. These decisions are expected to be made at the December 2, 2016 CCP meeting.

This is an unpaid, voluntary position.

By submitting an application you are indicating you understand the time commitment required for CAB membership, and confirm that you are able and available to fully participate.
