## **Contra Costa County Public Works Department Special Conditions of Annual Transportation Permits**

Movement which violates the conditions of this permit is illegal and will cause this permit to be cancelled or suspended.

A reprinted or faxed copy of this permit is not valid authorization to move and can be used only for reference purposes.

Unless superseded by a special restriction written into or referenced on the face of this permit, all movements authorized by this permit shall be subject to the following conditions:

- 1. All moves shall conform to the requirements of Attachment 1, "Transportation Permit Conditions".
- 2. This permit is not valid on roads or bridges that have posted weight limits.
- 3. This permit shall be valid only on those roads listed under the applicable classification in Attachment 2, "Routes Authorized For Annual Transportation Permits", and any additionally roads written on the face of this permit, and is subject to the weight restrictions of Attachment 4 "Restricted Routes".
- 4. Pilot cars shall be provided as required by Column 5 "Pilot Car Requirements" in Attachment 2, or as required by any special restrictions written on the face of this permit.
- 5. If "Saturday" and "Sunday" movement is authorized on the face of this permit, it shall be in accordance to the restrictions of Column 3 "Weekend Movement" in Attachment 2.
- 6. If "Darkness" movement is authorized on the face of this permit, it shall be in accordance to the restrictions of Column 4 "After-Dark Movement" in Attachment 2.
- 7. Loaded vehicles in excess of 15'0" height, 14'0" width, or "bonus purple" axle group weights shall not be authorized for movement under this permit unless specifically written on the face of this permit.
- 8. This permit shall only be valid in conjunction with a valid California Department of Transportation Annual Transportation Permit. The state annual transportation permit number shall be referenced on the face of this permit and a copy of the state permit attached.
- 9. In the event-that adequate horizontal or at least three (3) inches vertical clearance does not exist at any point along the permitted route, it shall be the responsibility of the permittee to contact the County to request alternate routing. The permittee shall not dismantle or remove facilities, trim trees, make any other change to any road right-of-way, or detour from the authorized route, without the explicit approval of the County, except that in the event of an unforeseen problem, such actions, or others, may be authorized and directed by a uniformed peace officer.
- 10. The County reserves the right to require that any vehicle/vehicle combination/load be inspected, by the County, prior to the start of an authorized move. If required on the face of this permit, the permittee shall be responsible for contacting the designated person at least 24 hours prior to the planned move.
- 11. No existing roadway parking spaces may be blocked, restricted, or marked without the specific authorization of the County
- 12. The permittee shall be responsible for arranging a police escort if so specified on the face of this permit and whenever, in the course of the permitted move, blocking of a public road or detouring of traffic is required. Neither the permittee nor any associated pilot vehicle or flaggers shall attempt to block a public road or to detour traffic, except in the case of an extreme emergency.
